Stores/Supply Workers	Are roles performing material handling (including mail) functions such as inventory management, distribution/delivery in the facility	Procurement and Finance positions
Receivers	Are material handling roles responsible incoming materials	
Department Attendants	Are non-regulated individuals who support delivery of services provided by an eligible role.	Roles supporting excluded functions (e.g. Physio Assistants)
Client-facing Reception/ Administrative Workers	Must be direct, in person patient interaction onsite at the workplace Will be determined in consultation with management personnel.	Client facing does not include internal clients
